COLUMBIA COUNTY BOARD OF COMMISSIONERS BOARD MEETING

MINUTES

March 29, 2006

The Columbia County Board of Commissioners met in scheduled session with Commissioner Joe Corsiglia, Commissioner Rita Bernhard and Commissioner Anthony Hyde, together with John Knight, County Counsel and Jan Greenhalgh, Board Secretary.

Commissioner Corsiglia called the meeting to order and led the flag salute.

MINUTES:

Commissioner Bernhard moved and Commissioner Hyde seconded to approve the minutes of the March 22, 2006 Board meeting and March 22, 2006 Staff meeting. The motion carried unanimously.

DELIBERATION: RECHT/NELSON/RUSSELL ZONE CHANGE:

This is the time set for deliberations, "In the Matter of the Application of Dick Recht, Chris Nelson and Scott and Sue Russell for a Comprehensive Plan Amendment and Zone Change from FA-19 to PF-76 and from FA-19 to RR-5".

John Knight stated that this was before the Board two weeks ago and since that time John has received comments from Columbia Hills Development Company, Mike Sheehan and Scott Russell. Those comments were reviewed with the Board at the last work session. John has since made some revisions to the ordinance. He feels it would be premature to adopt this ordinance until all parties have had the chance to review the latest version. John believes the ordinance will be ready for action by next week. With that, Commissioner Hyde moved and Commissioner Bernhard seconded to continue deliberations on this matter to April 5, 2006, at or after 10:00 a.m. Commissioner Bernhard stated that she would not be present next week. The motion carried unanimously.

VISITOR COMMENTS:

Tammy Maygra, 34319 Cannan Road, Deer Island: Regarding the new Transfer Station, Tammy asked if there will be a scale to weigh vehicles before and after dumping garbage. That isn't the case at this time. The Board felt this was a good suggestion and will check into that with Todd Dugdale. Todd stated that he would meet with Tammy on that. Commissioner Corsiglia asked Todd to check on the incremental setting required by State weights and measures.

On another issue, she and Peggy Crisp attended a rally in Astoria yesterday and asked why this Board didn't attend. The Board stated that they had other engagements, however, Tom Fuller was there and reported back to the Board.

On a budget issue, Peggy sees where \$9,000 was budgeted for Asburry Acres under the Parks budget and asked what that is going for. Commissioner Hyde understood that was going towards the wetlands mitigation.

On Friday evening, she attended the first joint pageant for Miss River City Days, Miss Sauerkraut festival and Miss Columbia County. There are scholarships available for all of these contestants.

Last night she attended a public forum held by the City of St. Helens. They were soliciting ideas on how to better promote the downtown area.

COMMISSIONER HYDE COMMENTS:

Commissioner Hyde attended an AOC meeting in Salem last week to continue working on the reauthorization of PL 106-393.

Last week, he met with Vicki Harguth and Steve Sallee on the Strawman project for emergency management. This should be ready for Board approval soon.

There was no Executive Session held.

Commissioner Corsiglia noted that there will be a Columbia County Development Agency meeting at 11:00 a.m. today and a Staff meeting at 2:00 p.m. today.
