Hi Jack - thanks for taking my call last week regarding the substation. As discussed, the proposed substation for the expansion area is the same portable substation already in use on the existing Bates Roth site (photo attached for your records). The portable substation provides power to the electric dredge and moving it may not be required for several years dependent on mining progression. Thank you for your response and expressing NWA's willingness to accommodate our current workload constraints. While we appreciate your response, ORS 215.427(5) states that the period in which the County is required to take final action, as established by ORS 215.427(1), can be extended for a **specified period of time upon the written request of the applicant**. With that being said, we kindly ask that you outline **the specific number of days** NWA is requesting to extend the period by, as the statute requires that extensions be for a specific period. Additionally, while a 60-day extension would be ideal, a 30-day extension would be sufficient for the immediate hearing on March 3rd, with the understanding that we can process

additional extensions if needed. A clarifying email identifying the requested extension period is sufficient.

Thank you for the outreach. I received the email below on behalf of Northwest Aggregates Co (NWA). We sincerely appreciate the confirmation that the County is proceeding as quickly as it can on the review of our application. As I have indicated in voice messages to each of you, NWA has no intention of forcing an action within the

regulatory timeframe and has no objection to extending the time to act or having the matter on the March Planning Commission agenda. I am concerned, however, with my reading of the regulations as requiring an agreed upon time frame or there being a dispute requiring mediation. I am certainly not aware of any dispute (needing mediation or otherwise) and the proposed waiver does not have a time frame. Hi Jeremy,

As we have discussed over the phone, under the current timeline, we cannot schedule or send notice of your application for the March 3rd Planning Commission meeting until the applicant signs and submits the attached waiver of 120-day rule, which allows us to continue to process the application beyond the required decision/appeal period. More specifically, the 120-day period ends on 3/14/2025, with a 12-day required appeal period that begins the date the decision is noticed. Even if the application was noticed for approval on the date of the hearing (and if it is approved), the appeal period would conclude on 3/15/2025 – one day after the (3/14/2025) decision/appeal window concludes.

I understand that there was some confusion regarding what exactly the 120-day waiver entails and whether or not this would allow the County to push review of the application to an unspecified date.

I can assure you that we are looking to process, conduct review, schedule your application before the Planning Commission as soon as possible. Unfortunately, as we are short staffed this month – the earliest PC date has been pushed to the meeting on March 3rd.

I am reaching out to inform you that, due to unforeseen circumstances, we will need to reschedule your application from the Planning Commission meeting on 2/3/2025 to the meeting on 3/3/2025.
